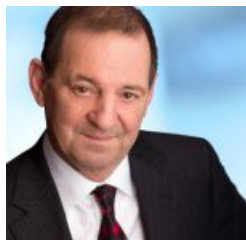

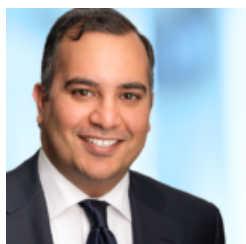

SELECT CASES

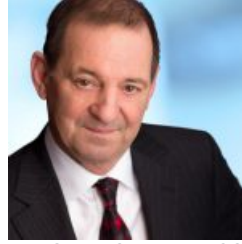

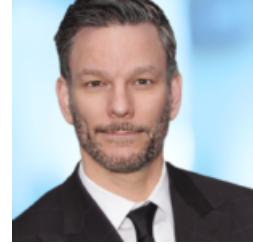
