MEDICAL LITIGATION

Kim is an acknowledged leader in the practice of health law, both for the quality of her legal work and for her tireless dedication to the field.

Kim has extensive court experience representing clients in complex medical malpractice cases and has appeared as counsel before all levels of court in B.C. including the B.C. Supreme Court and Court of Appeal. She has been lead or co-counsel on cases where decisions have and continue to define and guide this area of law. Select examples of her work include:

She has published on topics including expert witnesses, wrongful life and birth, and conflicts, a subject outside her area of expertise but of special interest to her. In 2018, Kim and Guy Brown, QC co-authored a chapter on Jury Trials in the 5th Edition of the CLEBC BC Civil Trial Handbook.

MAID

Kim has also developed niche expertise in the emerging legal field of MAiD (medical assistance in dying) and has played a prominent role in the study and implementation of legislation providing for medical assistance in dying.

She is Chair of the National CBA End-of-Life Working Group convened to study the legal and ethical issues surrounding end of life decisions and is committed to furthering the discussion and best practices in the new territory of medical assistance in dying.

On May 10, 2016, on behalf of the CBA, she presented before the Senate Standing Committee on Legal and Constitutional Affairs regarding Bill C-14, the proposed legislation to address MAID. She serves as a Member of the Legal Advisory Committee, a standing committee of the Board of Directors of Dying with Dignity Canada. Her work in this area is having a profound impact on individuals and families across Canada.

PROFESSIONAL REGULATION AND ADMINISTRATIVE LAW

In addition to her civil litigation practice, Kim provides guidance to professional regulatory bodies, associations, and individuals on matters such as data protection, discipline, dispute resolution and litigation, policies and procedures, and general advisory support.

She has extensive experience in assisting physicians, nurses, naturopathic doctors, veterinarians and engineers in regulatory matters. She regularly advises clients in professional regulation matters touching on issues of complaints, disciplinary issues, ethics, fraud allegations, investigations, privacy and confidentiality, capacity, and other related issues.

In her mediation practice, Kim has the advantage of being able to draw on the unique insights, perspectives and skills she has cultivated in her legal practice. For example, through her regulatory practice experience she has gained a keen understanding of the dynamics of the workplace (particularly in high stress environments) and how important facilitated resolution of workplace disputes can be to improving or restoring harmony in the workplace. She believes that every voice needs to be heard in a safe environment and is committed to ensuring that all parties to the dispute feel that her role in the process fills that need. In her experience, facilitating resolution where all parties feel their needs are met results in better workplace relationships.

As a mediator she is people and outcome focused and unflinchingly impartial. She advocates for an outcome, not a party. In the role of mediator she actively listens, finds common ground and shared interests, and helps facilitate supportable and lasting agreements.
