CONTRACTUAL/QUASI-CONTRACTUAL DISPUTES

This culminated in a five-week hearing in the BC Supreme Court, followed by a hearing in the BC Court of Appeal. The matter involved issues such as the nature of ecclesiastical corporations, the exigibility of charitable trust assets, and the division of powers between the federal insolvency power and the provincial power over property and civil rights.
